














LIST OF PROPERTY OWNERS

The following list contains the names of the owners of record, (in 1969) for the properties which lie within the project boundaries.

Subsequent research into the ownership of the land in the McCauley Run area revealed that the tax records (from which the list was taken) contain many errors and that the tax maps contain errors.

The attached property map was taken from a map made in the late 1800's and which appears to be more accurate than any other map available.

In the early stages of the project letters were sent to each property owner listed for permission to enter on the land, with the result that many did not reply, others replied that they no longer owned the land and some replies stated that the individual was deceased.

Except for the area of McCauley Run, no attempt was made to establish the true present owners due to the great time expenditure required and since this was not a part of the contract.


